

## General Waiver and Release Form Parental / Guardian Release

The undersigned desires to undertake aviation orientation activities including flying that may be offered by the Leading Edge Flying Club, and/or the Experimental Aircraft Association and its chapters (collectively referred to as "EAA") between the date this agreement is executed and **September 30, 2012**. These activities will be conducted at no charge, by qualified pilots in accordance with the applicable FAA regulations.

The undersigned acknowledges that these activities are NOT SPONSORED OR AFFILIATED with Aviation Explorer Post 9, Learning for Life, or the Boy Scouts of America. The undersigned acknowledges and assumes all risks associated with and waives and releases Aviation Explorer Post 9, Learning for Life, the Boy Scouts of America, the Northwest Suburban Council, the Leading Edge Flying Club, the EAA, and their officers, employees, and volunteers, from any and all liability related to or arising out of any activities, known and unknown, including without limitation medical expenses, legal fees, loss of services, etc., and shall indemnify and hold all of them harmless from and against any such item.

The undersigned warrants that he or she is in good health and is suffering from no debilitating ailment that would affect his or her performance in any manner or jeopardize the health or safety of other persons in or around an Aircraft.

Without limiting the foregoing, the undersigned warrants that he or she is not affected by high blood pressure, a heart condition, asthma, arthritis, diabetes, or any other health impairment. The undersigned acknowledges that he or she may be subject to exposure to some hazardous aviation materials such as oil, aviation gasoline, and may come in contact with high performance engine parts, as well as traveling and performing maneuvers at high speeds and altitudes. These examples are meant to establish that the undersigned has knowledge of some of the many risks being assumed.

In signing hereunder, the undersigned assumes the entire risk for any injury, liability or other consequences of involving himself or herself with any of the activities undertaken as previously described. In doing so, the undersigned hereby waives and releases Aviation Explorer Post 9, Learning for Life, The Boy Scouts of America, the Northwest Suburban Council, the Leading Edge Flying Club, the EAA, and their officers, member pilots, associates, employees, and volunteers from any and all liability arising out of aforementioned activities, known and unknown, including without limitation, medical expenses, legal fees, loss of services, etc., and shall indemnify and hold all of them harmless from and against any such item.
